New Definition of Resident - effective April 29, 2004	<p>B.C. Resident means:</p> <p>(a) a person who</p> <ol style="list-style-type: none"> 1. is a Canadian citizen or a permanent resident of Canada, whose only or primary residence is in British Columbia, AND has been physically present in British Columbia for the greater portion of each of 6 calendar months out of the 12 calendar months immediately preceding the date of making an application under this Act or doing another thing relevant to the operation of this Act, <p>OR</p> <p>(b) a person who</p> <ol style="list-style-type: none"> 1. is not a Canadian citizen or a permanent
