## Message from the Chair

It has been an extremely busy first year of my appointment. A request from the Minister to review the operations and mandate of the Agricultural Land Commission (ALC) shortly after I was appointed took a substantial amount of focus and energy. Myself and a committee of Commissioners along with staff met with 60 stakeholder groups and over 300 individuals across the province over a very short period of time in the fall of 2010. I submitted my final report to the Minister November 26, 2010 and I am waiting for further government direction on the recommendations contained in the report. A significant amount of time and resources were devoted to this request.

The stakeholder meetings were invaluable and provided very useful feedback regarding the work of the ALC. It was clear that there is overwhelming support for the Agricultural Land Reserve (ALR) program and I believe this support is a sign that after almost 40 years, the relevance of the ALR is no longer in question and that the ALC should explore new opportunities to strengthen the program. However, stakeholders were almost unanimous in expressing their concern regarding the inadequacy of the ALC's resources to carry out its existing work, never mind explore new opportunities. This exercise was very helpful to me in my new role as Chair.

In September 2010, the BC Auditor General issued his audit report. The audit found that the ALC is challenged to effectively preserve agricultural land and encourage farming in British Columbia, specifically:

- the ALC has not determined that the boundaries of the ALR are accurate and include lands that are both capable of and suitable for agricultural use;
- the ALC has identified limitations in its ability to preserve agricultural land and encourage farming through the application process;
- the ALC is not sufficiently involved in proactive long term land use planning with local governments to encourage farming on a broad basis; and
- oversight of the decisions made by its "delegated authorities" needs strengthening to ensure that agricultural land is being preserved and farming encouraged.

The ALC has had limited opportunity to respond to the recommendations set out in the audit during the course of the past year.

Despite resource constraints, the ALC continues to strive to work with others to ensure ALR land is preserved and farming is encouraged. Besides responding to the constant flow of applications, the ALC makes every attempt to pursue other functions related to its mandate including working with local governments to ensure they are planning for agriculture and appropriately acknowledging the ALR in their community planning exercises. Ongoing provincial government initiatives including climate action, carbon offsets, large scale utility and transportation projects also require attention by the ALC.

An important change introduced in this annual report deals with a new reporting method for statistical information. While the ALC's new database and reporting tool (OATS) is not as functional as was hoped due to technical inadequacies, the ALC wishes to improve how it reports its decisions and hopes this new reporting format will better reflect the decisions of the ALC.

Please also note that in light of operational challenges facing the ALC and the transition between Chairs, this Annual Report covers fiscal years 2009/10 and 2010/11.

## Mission and Purpose

The Agricultural Land Commission (ALC) is the provincial agency responsible for administering the Agricultural Land Reserve (ALR), a provincial land use zone for agriculture. The purposes of the ALC as set out in legislation are:

- (a) to preserve agricultural land;
- (b) to encourage farming on agricultural land in collaboration with other communities of interest; and
- (c) to encourage local governments, First Nations, the government and its agents to enable and accommodate farm use of agricultural land and uses compatible with agriculture in their plans, bylaws and policies.

The *Agricultural Land Commission Act (ALC Act)* sets out processes for the inclusion or exclusion of land to and from the ALR and for non-farm use and subdivision of land within the ALR. The *ALC Act* is supported by the Agricultural Land Reserve Use, Subdivision and Procedure Regulation (BC Regulation 171/2002), which provides procedures for applications and defines permitted land uses and subdivisions within the ALR.

As an administrative tribunal acting pursuant to the *ALC Act* and the *Administrative Tribunals Act*, the ALC considers each application on its individual merits through a fair and transparent review process.

The work of the ALC is carried out by 19 appointed Commissioners comprised of a Chair, 6 Vice-Chairs and 12 members. The appointed Commissioners are the board of directors of the Commission which is supported by 20 professional staff.



## Administrative Tribunal

**An administrative tribunal** is a specialized government agency established under provincial legislation to implement legislative policy. Appointment to such agencies is by order-in-council and in the case of the ALC, some members are appointed by Ministerial Order. Candidates for appointment are chosen for their knowledge and expertise and their experience in the particular sector being regulated by the legislation. As per its governing legislation, Commission members must be knowledgeable in matters relating to agriculture, land use planning, local government or first nation government. Administrative tribunals perform a wide range of functions, including research and recommendations; rule making and policy development; adjudication; and standard setting.

Administrative tribunals function at arm's length from government and are expected to exercise their role in a nonpartisan manner. However, the precise relationship between administrative tribunals and government varies.



## The Board

**The Agricultural Land Commission** is administered by a government-appointed commission consisting of 19 board members comprised of a Chair, six Vice-Chairs and 12 Commissioners. For administrative efficiency and regional responsiveness the ALC operates as 6 panels for its 6 geographic regions of the province. Each panel has three members - a Vice-Chair and 2 Commissioners appointed from the region for which they are responsible.

The 19 member board is the provincial body of the ALC. The ALC is not, as is often thought, the aggregate of 6 regional commissions.

## Executive Committee

The Executive Committee consists of the Chair and the 6 Vice-Chairs. The Executive considers and decides on matters related to:

- Strategic Planning
- Business Planning
- Policy Development
- Issues of province-wide importance
- Monitoring and Coordination of Panel Operations

The Executive Committee met for 3 days in fiscal 2009/10 and in 2010/11. Topics of discussion included strategic policy, business planning, governance and budget resource issues.



# Commission Office

The business of the Commission is carried out through four functional areas by a staff of 20.

- Land Use Planning and Application Processing:** Staff research and administer all applications submitted pursuant to the *Agricultural Land Commission Act* and Regulations as well as performing compliance and enforcement related duties. In addition, they also review plans and bylaws of local governments and other agencies to ensure that the ALR is properly identified and that the policies support the objectives of the Act and Regulations.
- Compliance and Enforcement:** The ALC has a legislative mandate to ensure activities in the ALR are consistent with the Act, regulations and orders of the ALC.
- Strategic Planning and Corporate Policy:** Staff actively participates with Commissioners in developing strategies, plans and policies to achieve the goals and objectives set out in its Business Plan. Staff also participates in the agricultural planning and policy initiatives of other ministries, agencies and local governments.
- Administration and Information Systems:** The previous three functions are supported by an administration, records management and information systems unit. This includes maintenance of an application database comprised of approximately 30,000 stored paper files and almost 11,000 stored paper and electronic files as well as over 1,400 ALR maps.

# Panel Operations

The panels consist of a Vice-Chair and 2 Commissioners. Panels are responsible for:

- Decisions on applications
- Plan and bylaw reviews
- Field inspections
- Meeting with individuals, local governments, farm organizations and other government representatives

Panels report their regional activities through the Vice-chair to the Executive Committee. All decisions relating to applications and planning issues are made at the regional level by the panels. Decisions of a panel are final and cannot be appealed to the Executive Committee or the Board.

Commission panels met 58 days in fiscal year 2009/10 and again in 2010/11.

# Compliance and Enforcement

Compliance and enforcement staff continue to work with local governments to build relationships and work jointly on compliance issues. The ALC embarked on a pilot project that designated other provincial government compliance and enforcement officers as ALC Officials for the purposes of inspections. The ALC will continue its efforts to train and appoint resource management professionals in the coming years in order to assist the commission in providing extra “eyes and ears” in the field to report potential illegal activities within the ALR.

During the 2010\2011 fiscal year the ALC Compliance and Enforcement division continued to work with the Resource Management Coordination Program. Eleven Ministry of Forests and Range forestry officers in the lower mainland and sunshine coast were trained and designated as Officials with the ALC. They were called upon to conduct detailed inspections of 50 properties located in Surrey associated with unauthorized fill and truck parking activities.

The ALC designated Ministry of Forests and Range Compliance & Enforcement staff in the Chilliwack and Dawson Creek offices as “Officials” under the *ALC Act* to provide inspection and complaint response on behalf of the Commission. All complaints will still be coordinated by ALC staff.

# Planning and Operational Policy

## Ranching Task Force

The Ranching Task Force (RTF) which was initiated in 2009, identified government policies, regulations and legislation that may be hindering the competitive position of the B.C. cattle industry. The RTF was supported in this work by a cross-government team that developed recommended solutions to the identified regulatory challenges. The ALC participated in the process and responded to recommendations regarding the ALR.

The B.C. Cattlemen's Association canvassed its members regarding the Agricultural Land Reserve and produced a position statement and recommendations that became a focus of the Ranching Task Force. The three primary issues identified by the RTF related to the ALR included: homesite severance and intergenerational transfer of farm businesses; flexibility related to non-farm uses, processing of agricultural products and on-farm energy production and ALR boundary reviews to ensure accuracy in specific areas.

## Zero Net Deforestation Act

ALC staff participated in consultations regarding the *Zero Net Deforestation Act*. The ALC raised concerns that ZND has the potential to impact the ALR by either removing active agriculture from production by planting trees and/or discouraging land clearing for agricultural production. The ALC raised these concerns as they relate to its mandate to preserve agricultural land and to encourage farming of ALR lands. It is the ALC's position that the permanent planting of trees on ALR lands for afforestation purposes has the potential to alienate land from its primary and protected use of agriculture. While the goals of *ZND Act* are laudable, the ALC believes those objectives should not come at the expense of the ALR, agricultural production and the provincial agricultural economy.

## Chilliwack Boundary Adjustment Subdivision Review

The ALC conducted a review of subdivision approvals within the City of Chilliwack's boundaries involving boundary adjustments in the ALR. The review involved the assessment of all boundary adjustment subdivisions between April 1991 and February 2009 to determine if the approvals were made in accordance with the *Agricultural Land Commission Act* and the relevant land use and subdivision regulations under the *ALC Act* in force during the review period. In all, the ALC examined and evaluated approximately 250 files relating to boundary adjustment subdivisions. The purposes of the review were to review and assess the boundary adjustments made in the City; to assess the way in which the boundary adjustment decisions related to the long-term goal of preserving agricultural land and to suggest future courses of action as a result of the findings.

Of those boundary adjustment subdivisions considered relevant to the review the ALC believes 147 subdivisions were consistent and 66 were inconsistent with the regulations. The most significant impacts of the boundary adjustment subdivisions on the agricultural land base occurred when very small, or non-buildable parcels, were reconfigured into larger, building lots for rural residential



purposes. By both introducing rural residential parcels and using arable land for residential purposes, the agricultural land base has been negatively affected.

### **Tsawwassen First Nation Final Agreement Exclusion**

In accordance with the *Tsawwassen First Nation Final Agreement Act* and BC Regulation 34/2009 as passed by government of the Province of BC, the ALC amended its maps to reflect Government's 2009 decision to excluded 386.6 hectares of land from the ALR.



# Delegation Agreements

Delegation is the authorization by the ALC to a local government or other authority to act on its behalf to make use and subdivision decisions in the ALR under section 26 of the *Agricultural Land Commission Act*.

## Local Governments

1. Fraser-Fort George Regional District
  - In the 2009/10 the Regional District made 9 decisions under the delegated decision-making authority.
  - In the 2010/11 the Regional District made 20 decisions under the delegated decision-making authority.
2. Regional District of East Kootenay
  - In the 2009/10 the Regional District made 0 decisions under the delegated decision-making authority.
  - In the 2010/11 the Regional District made 4 decisions under the delegated decision-making authority.

## Oil and Gas Commission

- In 2009/10 a total of 683 oil and gas activities on ALR lands were exempted from making an application based on reporting and reclamation conditions. The OGC received 89 Schedule “B” post reclamation reports where ALR lands were no longer needed for oil and gas use. The OGC Commissioner approved 12 applications. Seventeen investigations and 15 enforcement actions took place.
- In 2010/11 a total of 661 oil and gas activities on ALR lands were exempted from making an application based on reporting and reclamation conditions. The OGC received 162 Schedule “B” post reclamation reports where ALR lands were no longer needed for oil and gas use. The OGC Commissioner approved/decided 0 applications. Three investigations and 2 enforcement actions took place.





## Chair Review

The Honourable Steve Thomson, Minister of Agriculture and Lands directed the Chair to conduct a review of the ALC regarding operations, policy, regulations and legislation over the course of a three month period - August to October 2010. The purpose of the review was to verify that the ALC is meeting its mandate while looking for ways to improve its decision making processes.

As part of the review, an ALC review committee travelled throughout the province and met with over 300 individuals from over 60 stakeholder groups. The stakeholder meetings were invaluable and provided very useful feedback regarding the work of the ALC.

The resulting report is a high level document that identifies issues and outlines recommendations, but does not go into the fine details on how the recommendations could be implemented. Further direction from government is required prior to the ALC developing an implementation plan. The report was submitted to the Minister of Agriculture in November 2010.

The ALC awaits further direction from government regarding the report.



# Auditor General Report

In September 2010, the BC Auditor General issued an audit report on the ALC <http://www.bcauditor.com/pubs/2010/report5/audit-agricultural-land-commission>. The audit was carried out to determine whether the ALC is:

- effectively preserving agricultural land and encouraging farming in British Columbia;
- adequately protecting the ALR from damage through its compliance and enforcement activities;
- adequately evaluating and reporting on its effectiveness.

The audit found that the ALC is challenged to effectively preserve agricultural land and encourage farming in British Columbia, specifically:

- the ALC has not determined that the boundaries of the ALR are accurate and include lands that are both capable of and suitable for agricultural use;
- the ALC has identified limitations in its ability to preserve agricultural land and encourage farming through the application process;
- the ALC is not sufficiently involved in proactive long term land use planning with local governments to encourage farming on a broad basis; and
- oversight of the decisions made by its “delegated authorities” needs strengthening to ensure that agricultural land is being preserved and farming encouraged.

The ALC has established policies to guide compliance and enforcement activities. However, the ALC has determined that the current staffing resources and enforcement tools to support those policies are not sufficient to protect the ALR from damage caused by unlawful actions such as illegal dumping of construction material. In addition, while the ALC is attempting to work with local and provincial governments to enhance compliance and enforcement activities, formal agreements are not yet in place.

The ALC is not effectively evaluating the results and impacts of its decisions, in part, because it lacks the necessary information. In addition, while it is reporting on some aspects of its success, it is not clearly describing the extent to which it is achieving its mandate.

Recommendations included:

- ensure that ALR boundaries are accurate and include land that is both capable of and suitable for agricultural use.
- seek government’s support to make changes that will allow it to more effectively preserve agricultural land and
- encourage farming through the application process.
- engage in proactive long-term planning with local governments to encourage farming.
- work with Fraser-Fort George Regional District to address concerns it has with the District’s processes.
- work with the Oil and Gas Commission to develop an action plan to implement the recommendations of the 2009 audit.
- ensure that it has a sufficiently robust compliance and enforcement program.
- prioritize completion of the new database and finalize conversion of the original paper ALR maps into digitalized format.
- evaluate the collective impacts of its decisions on applications and its broader policy decisions.
- report publicly on the cumulative impacts of its decisions.



# Mapping, GIS and Data Management

## Statistical Reporting Changes

The ALC transitioned to a new database called the Online Application Tracking System (OATS). Unfortunately, the database was not fully built as planned due to resourcing issues. Lack of funding for maintenance and fixes to reports and format has made the system less useful than expected. As a result, data entry has been difficult, mining of statistical data has been onerous and accuracy of reporting has been an issue. It was hoped that with the introduction of the new system, the ALC would have the ability to report out more accurately on the complexities of its decisions and link this data to a mapping component using Geographic Information Systems (GIS). However, this has not been the case.

Decision type is now being reported instead of application types received in order to report on what the ALC has actually decided.

A significant change has been made related to reporting of approvals. In the past the ALC reported combined data for approved and conditionally approved applications. The ALC is now reporting final approvals (no conditions to be met) separately from conditional approvals where if conditions of the decision are not met, the approval will expire. Applications will move from the conditionally approved 'box' to the final approved box when all conditions of an approval have been met and the approval will be considered final. If the conditions are not met and there is a time requirement, the conditional approval will expire. Net change to the ALR will now only reflect final decisions whereas it previously reflected both final and conditionally approved decisions.
