

# **Consensus Decision of the Alternative Payments Committee (APC)**

**December, 2010**

## **1.0 Purpose and Effect**

- 1.1** This document records the consensus decision of the APC, to make adjustments to the Salary Agreement and Service Contract Ranges (the "Ranges") established under the Alternative Payments Subsidiary Agreement (the "APSA") within the funding (the "Funding") provided under Article 2.04 of the Memorandum of Agreement dated April 6, 2009 between the Government, the BCMA and the MSC as amended by Amendment Number 1.
- 1.2** This consensus decision is binding upon satisfaction of the requirements for a consensus decision set out in section 1.2 of the Physician Master Agreement (PMA). The Government and the BCMA agree to execute and deliver any and all required documents and take any and all steps that may reasonably be required to carry out the consensus decision.
- 1.3** This document is subject to the terms of the PMA and the APSA. If there is any conflict or inconsistency between any terms of this document and any terms of the PMA or the APSA, the terms of those agreements will prevail.

## **2.0 The Consensus Decision**

- 2.1 Adjustments to Salary Agreement Ranges and Service Contract Ranges Effective April 1, 2010**
  - 2.1.1** Subject to Article 2.3 below, Salary Agreement Ranges are adjusted effective April 1, 2010 as set out in Appendices A1 through A6 to this consensus decision (the "2010 Adjusted Salary Agreement Ranges").
  - 2.1.2** Subject to Article 2.3 below, Service Contract Ranges are adjusted effective April 1, 2010 as set out in Appendices B1 through B6 to this consensus decision (the "2010 Adjusted Service Contract Ranges").
  - 2.1.3** The 2010 Adjusted Salary Agreement Ranges and the 2010 Adjusted Service Contract Ranges include the increases effective April 1, 2010 referred to in Article 2.06 of the MOA.

## **2.2 Adjustments to Salary Agreement Ranges and Service Contract Ranges Effective April 1, 2011**

**2.2.1** Subject to Article 2.3 below, the 2010 Adjusted Salary Agreement Ranges are further adjusted effective April 1, 2011 as set out in Appendices A1.1 through A6.1 to this consensus decision (the "2011 Adjusted Salary Agreement Ranges").

**2.2.2** Subject to Article 2.3 below, the 2010 Adjusted Service Contract Ranges are further adjusted effective April 1, 2011 as set out in Appendices B1.1 through B6.1 to this consensus decision.

**2.2.3** The 2011 Adjusted Salary Agreement Ranges and the 2011 Adjusted Service Contract Ranges include the increases effective April 1, 2011 referred to in Article 2.06 of the MOA.

## **2.3 Finalizing Range Adjustments**

**2.3.1** Prior to an Agency making any payments to physicians arising from any of the adjusted Salary Agreement or Service Contract Ranges, the Physician Compensation Branch of the Ministry of Health Services will work with the Agencies and the BCMA to prepare total costing at the level of individual Salary Agreements and individual or group Service Contracts in order to confirm that the full cost of implementing the adjustments is within the Funding.

**2.3.2** If the total costing performed under Article 2.3.1 shows the Funding is either exceeded or a portion unused, the APC will revise the Ranges, in the manner it determines to ensure the Funding is not exceeded.

## **2.4 Assignment to Practice Categories**


**2.4.1 General Practice - Defined Scope A:** General Practitioners who do not provide a Full Service Family Practice (as the term is used by the General Practice Services Committee) but are contracted or employed by an Agency to provide Physician Services in a focussed area of practice (i.e. palliative care, geriatrics, complex pain, mental health, sexual medicine) and possess recognized additional training are assigned to the practice category "General Practice-Defined Scope A". This also includes General Practitioners who provide cancer treatment services in a hospital and in the community (commonly referred to as "GP Oncologists") under a contract with the BC Cancer Agency, who will be transferred from the Full Scope B category to this Defined Scope A category, effective April 1, 2011.


- 2.4.2 General Practice - Defined Scope B:** General Practitioners who do not provide Full Service Family Practice (as the term is used by the General Practice Services Committee) are assigned to the practice category "General Practice-Defined Scope B.". This includes General Practitioners providing services at student health centres and those providing clinical assistant services in Intensive Care Units.
- 2.4.3 General Practice - Full Scope A:** General Practitioners who provide a Full Service Family Practice (as the term is used by the General Practices Service Committee) in a rural community, as defined in the Rural Practice Subsidiary Agreement and provide one or more of anaesthesia, obstetrics, general surgery and emergency services in a hospital or designated D & T Centre, are assigned to the practice category "General Practice (Full Scope A)".
- 2.4.4 General Practice - Full Scope B:** General Practitioners who provide a Full Service Family Practice (as the term is used by the General Practice Service Committee) in the community are assigned to the practice category "General Practice – Full Scope B."
- 2.4.5** Paediatricians who work under the supervision of other Physicians are assigned to the practice category "General Paediatrics (Defined Scope)". This includes General Paediatricians who provide ICU, SCN, or oncology services.
- 2.4.6** General Paediatricians who do not work under the supervision of other physicians are assigned to the practice category "General Paediatrics".
- 2.4.7** Specialist Physicians qualified to practice in the subspecialties of Cardiology, Gastroenterology, Endocrinology and Metabolism, Nephrology or Respiriology are assigned to the practice category "Subspecialty Internal Medicine A".

### **3.0 Implementation**

- 3.1** Subject to Article 2.3, physicians working under a Service Contract or Salary Agreement will be eligible to receive retroactive increases consistent with the 2010 Adjusted Salary Agreement Ranges and the 2010 Adjusted Service Contract Ranges.
