The revision number is indicated in the footer of the tables (e.g., Rev 1 is the first annual revision, etc., and Preliminary indicates it is the first release of data to December for that year). In addition to annual revisions, Statistics Canada revises the data for the previous data year every quarter (indicated in the footer by Rev Q1, etc) as well as with the release of the January and February data.
