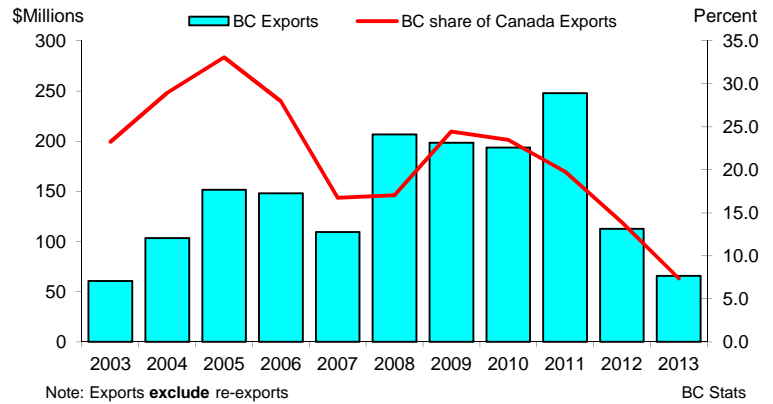

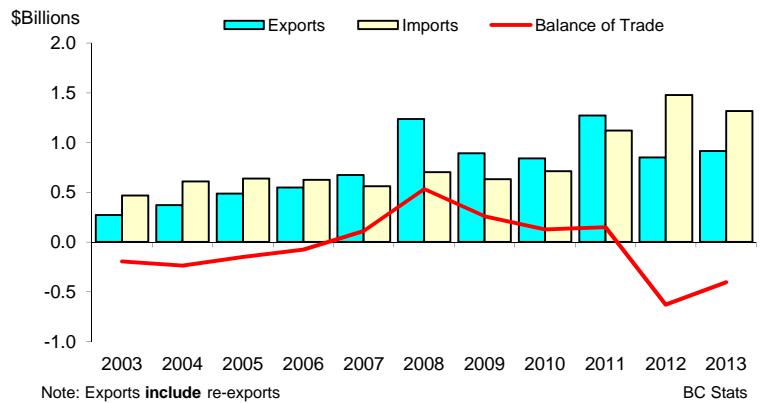
BC Origin Exports to Turkey

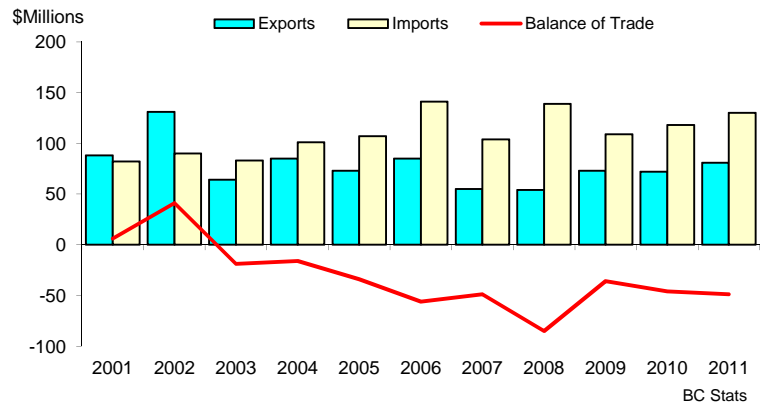
Canada's Balance of Trade in Goods with Turkey

How important is Turkey to BC and Canada?

Turkey ranked #28 as a destination for BC origin exports in 2013 with 0.2% of BC's commodity exports shipped there. It was ranked #22 as a destination for Canadian exports with 0.2% of Canadian goods exports shipped there and #35 as a source of imports into Canada with 0.3% of Canadian imports originating from Turkey.

How important is Canada to Turkey?

Canada was the source of approximately 0.3% of imports into Turkey in 2012. Approximately 0.5% of exports from Turkey were destined for Canada in that year.

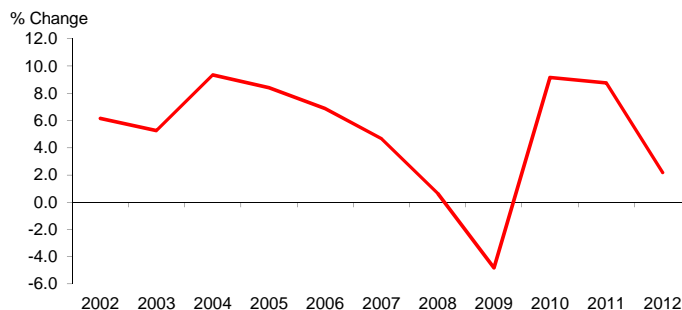

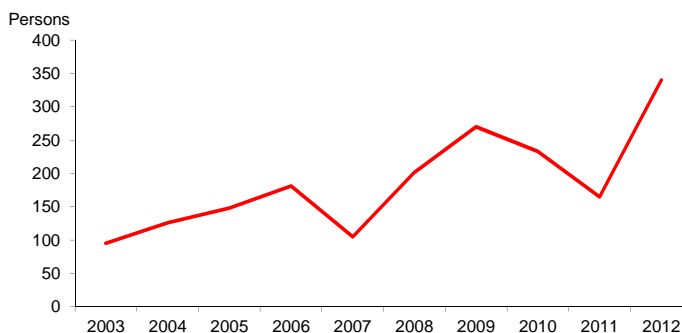
Year-Over-Year % Growth in GDP of Turkey

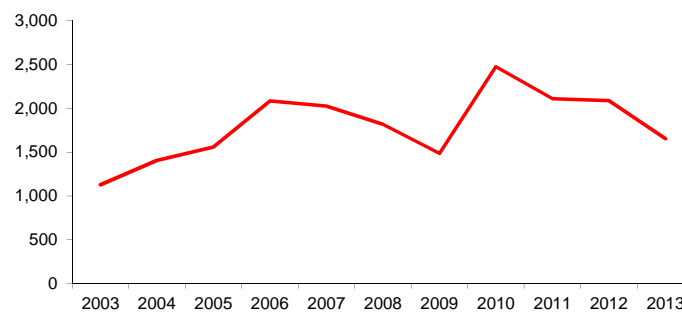
Immigrants to BC from Turkey
